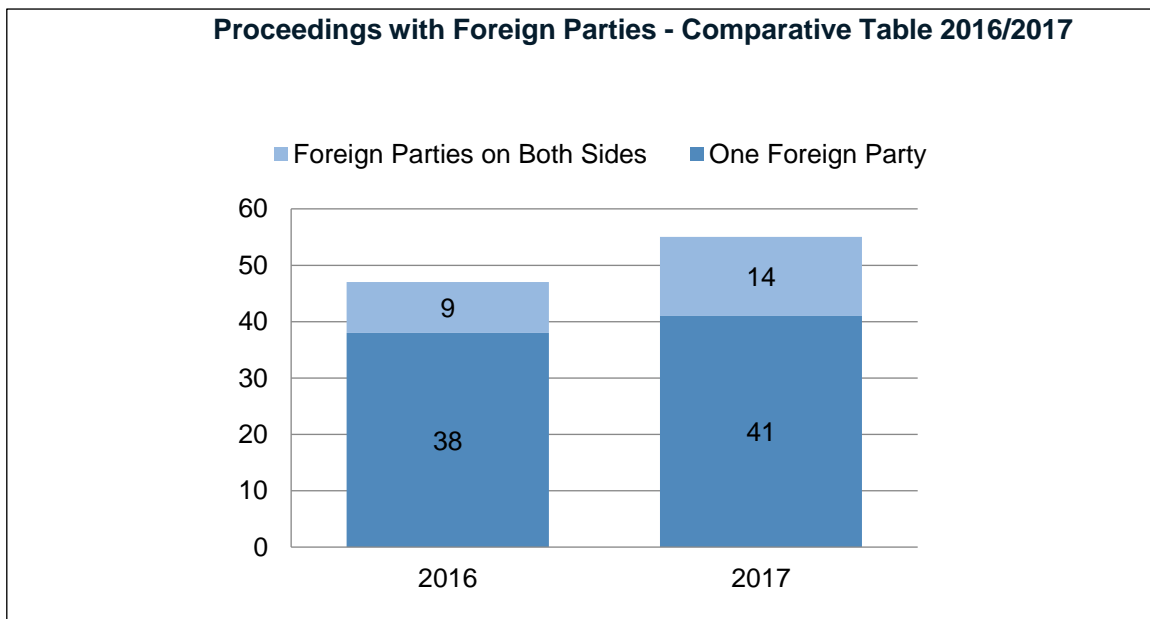
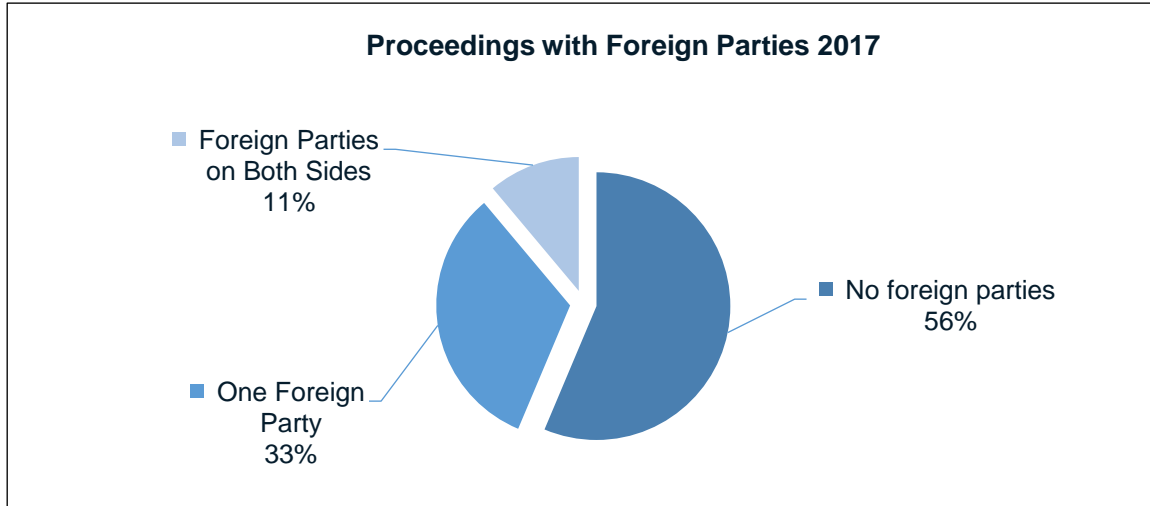
#### 4. Arbitration Proceedings – Language of the Proceedings 2017\*

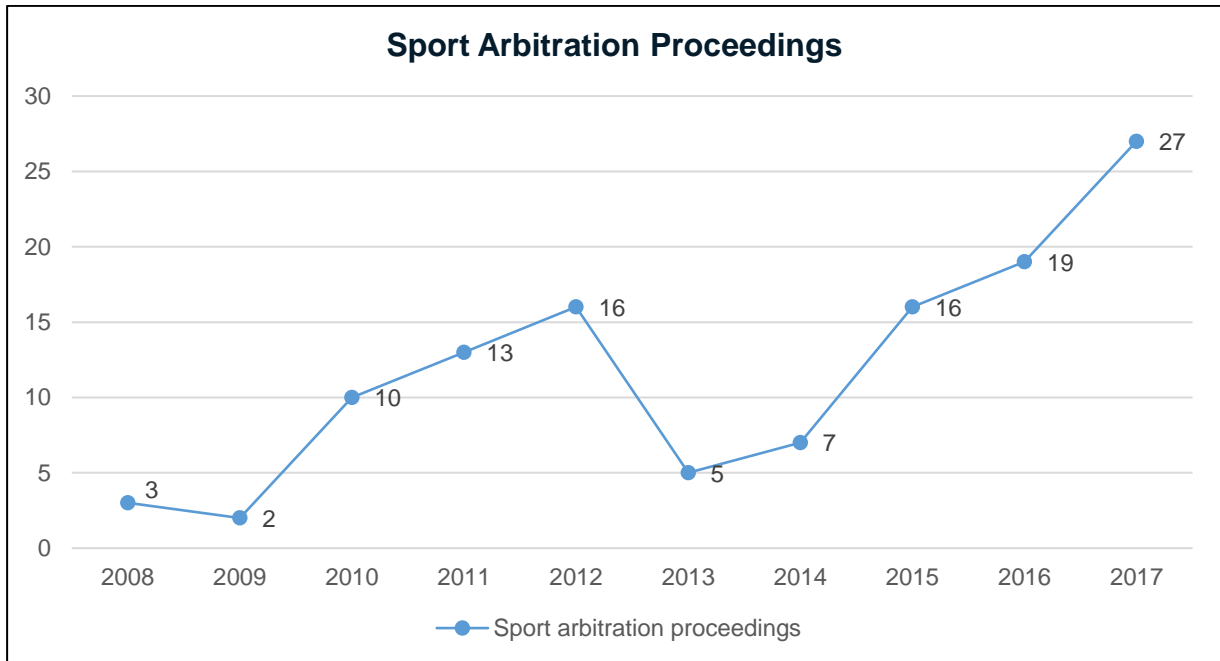

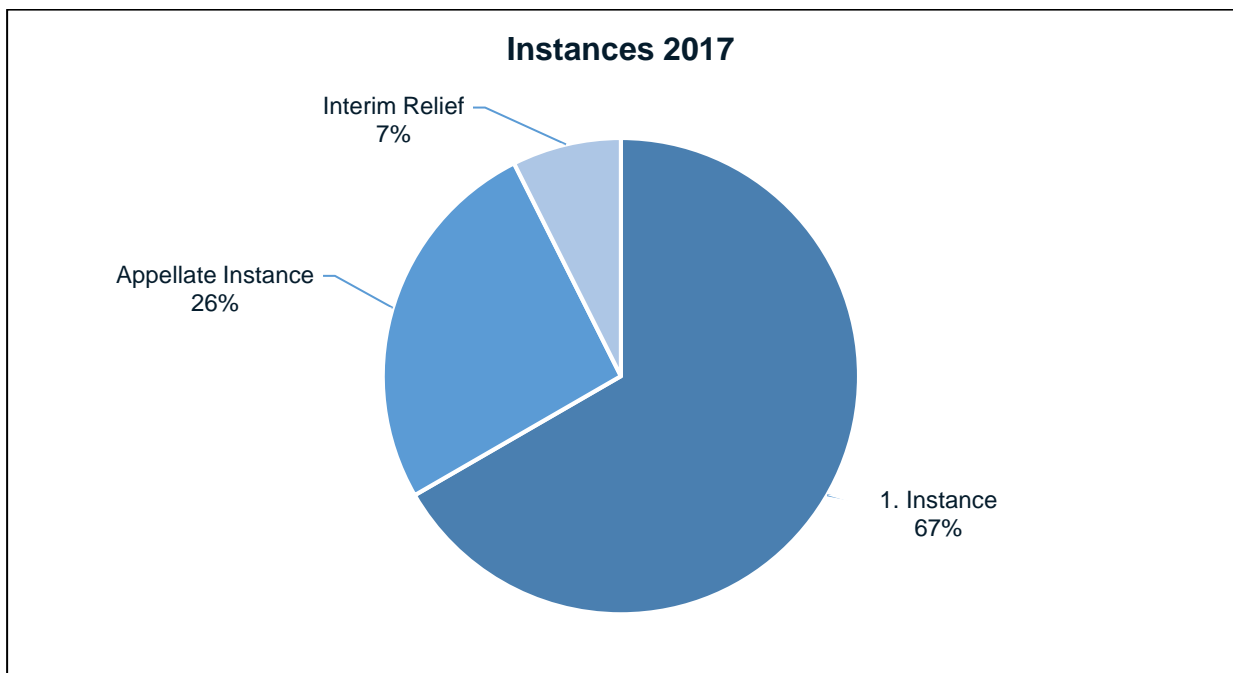

a) Dynamic development of the case load since the establishment of the German Court of Arbitration for Sport



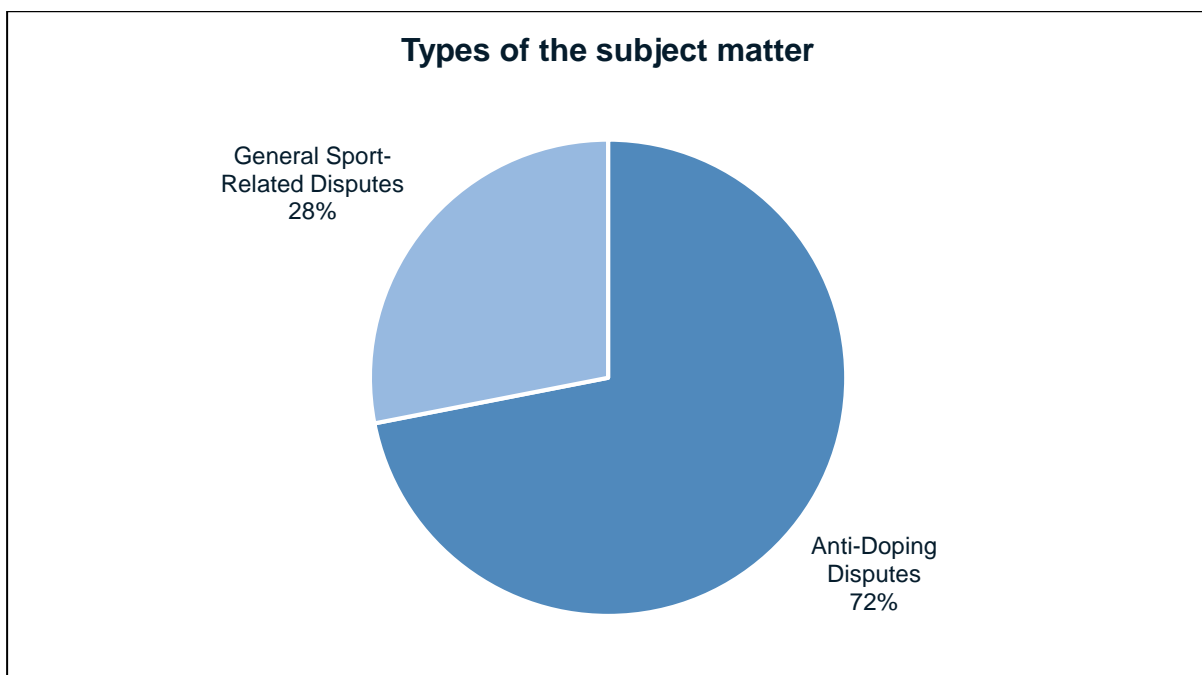
b) Stages of the proceedings (Instances)
